**SECTION 4**  
**FIRST AID MEASURES**

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure. Immediately consult a doctor should irritation occur.

## **SECTION 5**

### **FIRE FIGHTING MEASURES**

<b>Suitable Extinguishing Media:</b>	Use carbon dioxide, dry chemical, water fog or foam.
<b>Unsuitable Extinguishing Media:</b>	High volume water jet. Use a water jet only to cool heated containers.
<b>Specific hazards:</b>	Decomposes on heating, emitting toxic fumes including those of hydrogen chloride and phosgene.
<b>Special Fire Fighting Procedures:</b>	Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

<b>Personal Precautions:</b>	Avoid contact with skin and eyes. Do not breathe in spray mist or fumes. Ventilate area of spill or leak, especially in contained areas.
<b>Protective equipment:</b>	Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.
<b>Emergency procedures:</b>	Alert emergency personnel, evacuate unprotected personnel and animals.
<b>Environmental Precautions:</b>	Prevent spilled product from entering sewers, waterways, or ground water. Any spillages or uncontrolled discharges into watercourses should be reported immediately to the police and the Department of Water/Environmental Affairs.

#### **HANDLING**

**Precautions for safe handling:**

Avoid contact with skin and eyes. Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

**General occupational hygiene:**

Practice good hygiene when using this material. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

#### **STORAGE**
